GENERAL TERMS AND CONDITIONS

<u>Upon acceptance of your reservation and confirmation by Asian Hiking Team, members are supposed Clients</u>

/Participants of the trip/programs subject to all of the following terms and conditions:

- Asian Hiking Team reserves the right to reject or dismiss trip/programs to any individual at any time based on any factors.
- O Asian Hiking Team requires clients to be prepared physically, mentally and technically for particular trip.
- Clients/Participants must supply true, complete and accurate information on the personal registration form (including the, information concerning training and prior mountaineering experience for expedition), Clients Medical Information (only for expedition), Physician's Certificate (only for expedition), and in any other written or oral communications.
- o Reserves the right to change, alter or cancel the itinerary as in Asian Hiking Team sole discretion, we finds necessary for the proper and safe conducts of the program.
- Clients/Participants acknowledge that trip plans are necessarily subject to change based on a number of factors, including but not limited to foreign governments, weather, terrain, currency fluctuations, political issue and many other factors, and that we have complete discretion to effect any change of plans to accommodate any of these or other factors, including but not limited to increases in program fees, changes to the program schedule or itinerary, change of guides or staff, and changes to any means of conveyance, when deemed necessary or advisable, without notice and without allowance of refund and with the liability for any increased program fees, if any, to be borne by each client.

TRIPS FEES AND PAYMENTS

- o The programs fees is between Asian Hiking Team and clients/Participants communication by email or as website www.asianhikingteam.com
- Asian Hiking Team does not accept a part of trip fee at the end of your trip. All the trip fees are required to be fully paid before your trip start.
- Client need to pay 25 percent down payment of the total price for advance flight tickets, hotel booking and permit process. For expedition and flight ticket (only for expedition and international air ticket) Asian Hiking Team require you to send 50 percent of advance.
- O Advance Payments are wired by bank transfer, credit card, western union, money grams. Please, use any ways of transfer according to your convenience. However, please include wire fees charged by your bank or their correspondent bank(s). Wired information will be provided upon request.
- Balance of trip fees, need pay after your arrival in Kathmandu. We accept credit card, Nepali rupees or any foreigner currency as equivalent by current bank rate.
- o Late payments without notice will result in cancellation of program/trip or are not booking guarantee.

POLICY REGARDING CANCELLATION / NO SHOW / EARLY DEPARTURE

- o Asian Hiking Team reserves the right to cancel a trip for any reason prior of departure.
- o In case of cancellation of Tour services due to any avoidable/unavoidable reason/s you must be informed in writing.

- o 07 days prior to arrival 25% of the Tour cost (beside Tax, transportation, permits and others fixed). 48 hours prior to arrival 30% of the Tour cost (except Tax, transportation, permits and others fixed) and Less than 48 hours or no show NO REFUND.
- o In case of incomplete Trekking / Tour / Rafting / Jungles safari / or others days due to the client own problem the amount of money paid non-refundable and non-transferable. For unused hotel accommodation, chartered transportation and missed meals etc. we do not bear any responsibility to refund.
- o If clients want to do more days; Trekking / Tour / Rafting / Climbing / Expedition / Jungles safari / or others tours more than itinerary, they can pay after back from tour with per day basic but should be permission with Tour guide / Leader or from Asian Hiking Team, Thamel, Kathmandu.

REFUND

- o In regard to refund of unused/unutilized services (which are paid for and cancelled in advance) the refund amount would be worked out on the basis of cancellation policy as described above.
- The money would be accordingly refunded to the person who has made the payment to us. Please, note that the refund process may take 2-3 weeks due to banking procedures.
- o If the refund is made to the credit card amount or to bank account, the bank charges would be debited from the refund amount.

OTHER COSTS AND EXPENSES

- o Clients acknowledge that personal equipment (as Communication) are not includes in trip cost.
- O During the camping or climbing or expedition, clients acknowledge that all team or group supplies and equipment are the sole property of Asian Hiking Team.
- o (only for Expedition) During the climbing or expedition Clients agree to reimburse Asian Hiking Team for any satellite communication charges (if use satellite) incurred by Clients while participating in the program.
- Clients are required to carry approved travel insurance that includes medical evacuation, repatriation and medical expenses for the duration of their Trips.
- O Clients agree that the cost of any search and rescue undertaken on their behalf will be their financial responsibility.
- O (Special for Expedition) Clients/Participants acknowledge that during the program, certain events may occur which may necessitate certain additional costs not contemplated at this time, including but not limited to the cost of evacuation during any part of the program, medical treatment, body recovery and/or repatriation, and other related matters. Clients agree that those additional costs are not the responsibility of Asian Hiking Team and that the client is responsible for payment of those costs.
